3. HAZARDS IDENTIFICATION

PRIMARY ROUTE(S) OF EXPOSURE: Eye Skin Contact Skin Absorption

EFFECTS OF ACUTE EXPOSURE

EYES: May cause eye irritation. Symptoms may include redness and pain.

SKIN: May cause mild skin irritation. Symptoms may include redness.

INHALATION: High concentrations of vapor or mist may cause nose, throat and respiratory tract irritation. Symptoms may include coughing.

INGESTION: May cause mouth, throat and stomach irritation. Symptoms may include nausea, vomiting and diarrhea.

EFFECTS OF CHRONIC EXPOSURE: Prolonged or repeated contact may cause skin irritation.

MEDICAL CONDITIONS AGGRAVATED: May aggravate pre-existing eye, skin and respiratory conditions.

4. FIRST AID MEASURES

EYES: Flush eyes with plenty of water while holding eyelids apart. After initial flushing, remove any contact lenses and continue flushing for at least 15 minutes. Do not put any medication in the victim's eyes unless instructed by a physician. Get medical attention.

SKIN: Flush with water, then wash with soap and water. Remove saturated clothing. Get medical attention if irritation develops.

INHALATION: Remove to fresh air. If not breathing, give respiration; if breathing is difficult, give oxygen (by trained personnel only). Get medical attention if symptoms persist.

6. ACCIDENTAL RELEASE MEASURES

Contain and isolate spill. Keep non-essential personnel from entering spill area. Use mop, absorbent and non-sparking tools to collect material for proper disposal. Rinse area with water.

7. HANDLING AND STORAGE

HANDLING: Follow label use directions. Do not mix with other chemicals unless instructed by label directions. Avoid contact with eyes. Use with adequate ventilation. Use spark-proof tools. Do not expose to heat. Do not use near sparks, flames or pilot lights. Do not puncture or incinerate container. Wash thoroughly after handling. Remove contaminated clothing. Wash clothing and equipment before reuse.

STORAGE: Keep container closed when not in use. Store away from incompatible materials. (See Section 10, Stability and Reactivity). Store away from direct sunlight. Keep away from heat, sparks and flame. Do not store at temperatures above 120 F (49 C).

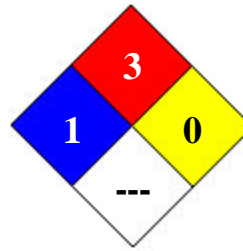
